Atomy's commission distribution structure

Commission paid within 35% of total company sales.

Basis of payment for membership level, General commission, Mastership commission, and education commission.

The total commission paid to members is calculated as 70% of the the PV earned.

(If it exceeds 35% of total sales, it will be automatically deducted.)






Mastership commission: 20% of entire sales PV will be distributed according to mastership.







* Even while maintaining Semi-Sales afterwards, personal PV accumulated during the period can be pooled with small leg


